

CONTRACT AGREEMENT

THIS AGREEMENT made this 23rd day of December, 2021 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and MARK ANTHONY LATUNA LADESMA Called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **PROCUREMENT** OF 2-UNIT PATROL BIKE FOR USE OF THE SK 3 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum **Seven Hundred Fifty Eight Thousand Pesos** (P 758,000.00) (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications of the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

iii. Performance Security;

v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> <u>additional contract documents or information prescribed by the GPPB</u> <u>that are subsequently required for submission after the contract execution,</u> <u>such as the Notice to Proceed, Variation Orders, and Warranty Security,</u> <u>shall likewise form part of the Contract.</u>

3. In consideration for the sum of Seven Hundred Fifty Eight Thousand Pesos (P 758,000.00) or such other sums as may be ascertained, DASH ENTERPRISES agrees to viz PROCUREMENT OF 2-UNIT PATROL BIKE FOR DSE-OF THE SK 3 in accordance with his/her/its Bid.
