CONTRACT AGREEMENT

THIS AGREEMENT made this 24th day of September , 2020 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and ARIEL D. DESPUIG , Proprietor of ARSSI CONSTRUCTION AND SUPPLY (hereinafter called the "Supplier") of the other part:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluations.


