CONTRACT AGREEMENT

THIS AGREEMENT made this **24th** day of **September**, **2021** between **Ma. Ester E. Hamor**, **City Mayor, City of Sorsogon** Philippines (hereinafter called the " Entity") of the one part and **ABELARDO A. 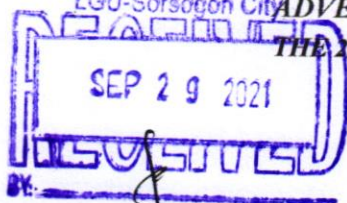

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;



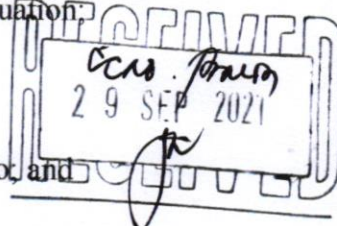
- iii. Performance Security;


