CONTRACT AGREEMENT

THIS AGREEMENT made this 8th day of October , 2021 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and RITCHELDA P. SARMIENTO proprietor of SAMKITS ENTERPRISES (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **PROCUREMENT OF VARIOUS MATERIALS FOR THE REPLACEMENT OF FLAGLET AT VARIOUS BRIDGES FOR THE 4TH QTR** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Sixty One Thousand Two Hundred Fifty Five Pesos (P 61,255.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation of the bid.

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

CIVIL SECURATY UN consideration for the sum of Sixty One Thousand Two Hundred Fifty Five LGU-Sorsogon CiPesos (P 61,255.00) or such other sums as may be ascertained, <u>SAMKITS</u> <u>ENTERPRISES</u> agrees PROCUREMENT OF VARIOUS MATERIALS FOR THE OCT 1 4 202 REPLACEMENT OF FLAGLET AT VARIOUS BRIDGES FOR THE 4th QTR QTR in accordance with his/her/its Bid. 4. The <u>City Government of Sorsogon</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
