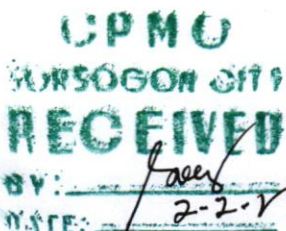
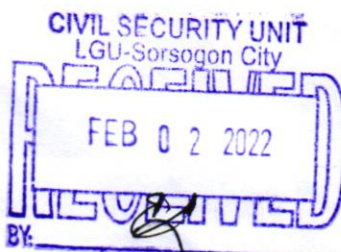

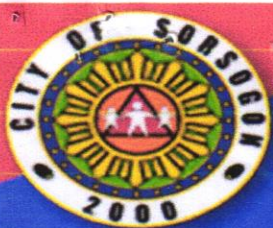

CONTRACT AGREEMENT

THIS AGREEMENT made this **28th** day of **January**, **2022** between **Ma. Ester E. Hamor**, **City Mayor, City of Sorsogon** Philippines (hereinafter called the " Entity") of the one part and **JOSE BONIFACIO L. LASALA** proprietor of **JL ENTERPRISES** (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **PROCUREMENT OF COMPUTER SETS WITH PRINTERS FOR USE AT THE SUSTENIR PROGRAM, CITY MAYOR'S OFFICE & BUS.  - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of **Three Hundred Three Thousand Six Hundred (P303,600.00) Pesos Only** or such other sums as may be ascertained, **JL ENTERPRISES** agrees to **PROCUREMENT OF COMPUTER SETS WITH PRINTERS FOR USE AT THE SUSTENIR PROGRAM, CITY MAYOR'S OFFICE & BUS. ONE STOP SHOP (CEO)** in accordance with his/her/its Bid.
