CONTRACT AGREEMENT

THIS AGREEMENT made this 28th day of February , 2022 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the " Entity") of the one part and JOSE BONIFACIO L. LASALA proprietor of JL ENTERPRISES (hereinafter called the "Supplier") of the other part:
