

### **CONTRACT AGREEMENT**

THIS AGREEMENT made this 4th day of March , 2022 between Ma. Ester E. Hamor , City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and MARK Proprietor of DASH ENTERPRISES (hereinafter called the ANTHONY LATUNA LADESMA "Supplier" ) of the other part:

Other contract documents that may be required by existing laws and/or the V. Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.


