

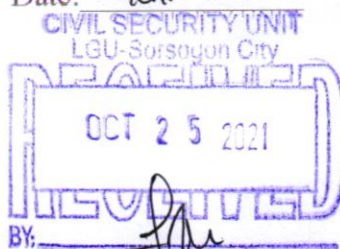

## CONTRACT AGREEMENT

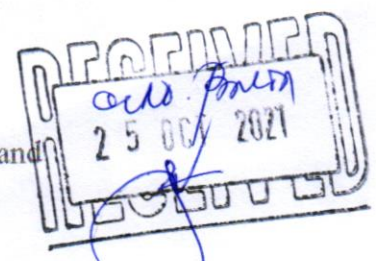
THIS AGREEMENT made this **15th** day of **October**, **2021** between **Ma. Ester E. Hamor**, **City Mayor, City of Sorsogon** Philippines ( hereinafter called the " Entity" ) of the one part and **LILIBETH V. VALDEZ** Authorized Representative of **ARMSCOR SHOOTING CENTER, INC.** ( hereinafter called the "Supplier" ) of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **PROCUREMENT OF AMMUNITION AND FLASH BANG GRENADE FOR SORSOGON CITY PNP** during the State of Health Emergency and has accepted a Bid by the Supplier for the supply of those goods and services in the sum **THREE HUNDRED THIRTY FIVE THOUSAND PESOS ONLY ( P 335,000) Only** ( hereinafter called "the Contract Price").

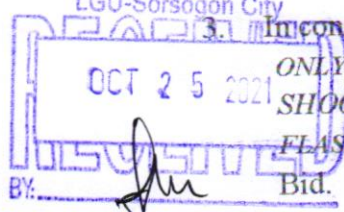
- i. Philippine Bidding Documents (PBDs);

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conform to thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
