## **CONTRACT AGREEMENT**

THIS AGREEMENT made this 28th day of February , 2022 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and JOSEPH MARK M. PARAS, Proprietor/Publisher of SORSOGON TODAY (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **PUBLICATION OF THE CITY ORDINANCES BY THE CITY VICE MAYOR'S OFFICE** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Three Hundred Seventy two Thousand Six Hundred Pesos (P 372,600.00 ) Only** (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> <u>additional contract documents or information prescribed by the GPPB</u> <u>that are subsequently required for submission after the contract execution,</u> <u>such as the Notice to Proceed, Variation Orders, and Warranty Security,</u> <u>shall likewise form part of the Contract.</u>
