**RESOLUTION APPROVING AND AUTHORIZING THE CONDUCT OF 4- COCK
DERBY ON JANUARY 8, 2022 AT THE GUINLAJON COCKPIT COLISEUM, BRGY.
GUINLAJON, WEST DISTRICT, SORSOGON CITY**

WHEREAS, it is a declared policy of the government to issue within framework of the society maximum development and promotion of wholesome recreation and amusement beneficial to the people;

WHEREAS, Section 458 (3)(v) of Republic Act 7160, otherwise known as the Local Government Code of 1991 authorizes through an ordinance the establishment, operation and maintenance of cockpits, and regulate the cockfighting and commercial breeding of gamecocks;

WHEREAS, as per consensus, a certain amount of the total share of the requesting party from the cockfighting activity shall be reserved and retained by the committee on Games and

Amusement through the owner of the cockpit and shall be given to identified charitable institutions in the City of Sorsogon and that the party shall faithfully comply therewith;

WHEREAS, the Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases by way of its Resolution No. 154 explicitly declared that as long as there are no objections from the Local Government Units where the activity may take place, operation of cockpits and traditional cockfighting shall be allowed in areas under Alert Level 2, subject to the strict observance of specific protocols;

WHEREAS, the 7th City Council on its Resolution No. 440, Series of 2021, resolved to allow the conduct of traditional cockfighting activities in authorized cockpits in the territorial jurisdiction of the City of Sorsogon in consonance with Inter Agency Task Force No. 154, series of 2021 dated December 14, 2021 and the relevant provisions of Presidential Decree 449 otherwise known as the Cockfighting Law of 1974;

WHEREAS, pursuant to existing laws and regulations and as provided by Republic Act 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Panlungsod has the power to regulate the conduct of cockfighting within the territorial jurisdiction of the city;

NOW THEREFORE, on incidental motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolved as it is hereby resolve to approve and authorize the conduct 4-COCK DERBY ON JANUARY 8, 2022 AT THE GUINLAJON COCKPIT COLISEUM, BRGY. GUINLAJON, WEST DISTRICT, SORSOGON CITY.
