RESOLUTION REITERATING THE REQUEST OF THE SANGGUNIANG PANLUNGSOD ADDRESSED TO ATTY. MARTIN B. DELGRA, III, CHAIRMAN, LAND TRANSPORTATION FRANCHISING REGULATORY BOARD (LTFRB) STRONGLY APPEALING THE EXTENSION OF CONSOLIDATION OF PUBLIC UTILITY JEEPNEYS (PUJ'S) IN THE PUBLIC UTILITY VEHICLE MODERNIZATION PROGRAM (PUVMP).

WHEREAS, on November 23, 2021, the 7th City Council passed and approved Resolution No. 382, series of 2021 entitled "RESOLUTION RESPECTFULLY REQUESTING ATTY. MARTIN B. DELGRA, III, CHAIRMAN, LAND TRANSPORTATION FRANCHISING REGULATORY BOARD (LTFRB) TO EXTEND THE CONSOLIDATION OF PUBLIC UTILITY JEEPNEYS PUJ'S) IN THE PUBLIC UTILITY VEHICLE MODERNIZATION PROGRAM (PUVMP)";

WHEREAS, knowing the deadline set by Land Transportation Franchising Regulatory Board (LTFRB) in relation to the herein mentioned consolidation, many if not all failed to submit their respective applications for consolidation because of financial constraints brought about by COVID 19 Pandemic;

WHEREAS, in addition thereof, the 7th City Council hereby invokes Section 16 of Republic Act 7160 otherwise known as the Local Government Code of 1991 under General Welfare Clause wherein sanggunian intends to protect the interest of its local inhabitants especially this trying times;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution REITERATING THE REQUEST OF THE SANGGUNIANG PANLUNGSOD ADDRESSED TO ATTY. MARTIN B. DELGRA, III, CHAIRMAN, LAND TRANSPORTATION FRANCHISING REGULATORY BOARD (LTFRB) STRONGLY APPEALING THE EXTENSION OF CONSOLIDATION OF PUBLIC UTILITY JEEPNEYS (PUJ'S) IN THE PUBLIC UTILITY VEHICLE MODERNIZATION PROGRAM (PUVMP).
