**RESOLUTION ADOPTING BUDGET CIRCULAR NO. 2021-2 DATED AUGUST 25, 2021 OF THE DEPARTMENT OF BUDGET AND MANAGEMENT AND FURTHER DIRECTING THE CITY HUMAN RESOURCE MANAGEMENT OFFICE TO COMMENCE MODIFICATION OF NURSE POSITIONS AS THEREIN PROVIDED.**

**WHEREAS**, on December 21, 2021 the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City and Members of the 7<sup>th</sup> City Council respectfully requesting for the passage of an ordinance effecting the Modification of Nurse Positions pursuant to Budget Circular No. 2021-2 dated August 25, 2021 of the Department of Budget and Management (DBM).

**WHEREAS**, the matter was officially jointly referred to the Committee on Personnel and the Committee on Finance as a matter of procedure;

**WHEREAS**, on January 10, 2021, a Joint Committee Hearing was conducted for the purpose inviting the presence of the City Budget Officer, City Human Resource

Management Officer and Members of the Committee on Personnel and the Committee on Finance and Appropriation;


