**RESOLUTION APPROVING THE OFFICIAL CANCELLATION/REVOCAION OF TWO (2) TRICYCLE FRANCHISES AS HEREUNDER IDENTIFIED FOR VIOLATION OF SECTION 20 OF CITY ORDINANCE NO. 22, SERIES OF 2020 OTHERWISE KNOWN AS THE “SORSOGON CITY NEW TRICYCLE FRANCHISE CODE OF 2020”**

**WHEREAS**, the following Tricycle Franchises are hereby officially cancelled and revoked in favor of the city government of Sorsogon for violation of Section 20 of City Ordinance No. 22, Series of 2020 otherwise known as the “Sorsogon City New Tricycle Franchise Code of 2020”, to wit:

- Tricycle Franchise No. 3296/Tricycle Franchise Plate No. 3296** awarded in the name of **ARLAN J. LACAMIENTO** of Barangay Salog, East District, Sorsogon City, with the route covered by SOTRIDA and with the following motorcycle technical description, to wit:

2. **Tricycle Franchise No. 2948/Tricycle Franchise Plate No. 2948** awarded in the name of **LUISITO B. LUSUEGRO** of Barangay Cambulaga, West District, Sorsogon City, with the route covered by SCIKWA and with the following motorcycle technical description, to wit:

**WHEREAS**, Section 20 of City Ordinance No. 22-2020 (“Sorsogon City New Tricycle Franchise Code of 2020”) provides:

**SECTION 20 GROUND FOR CANCELLATION AND REVOCATION OF FRANCHISE**

The following are grounds for the cancellation and revocation of Tricycle Franchise:

1. Violation of any provision herein and of the terms and conditions in the franchise;
2. Violation of related laws and ordinances;
3. Any motor vehicle involved in the commission of crimes other than those defined by the Revised Penal Code (RPC) as reckless imprudence shall be a cause for an automatic revocation of franchise and be permanently banned from being a franchise holder, unless the franchise grantee can submit the lower court’s findings of non-culpability;
4. Any motor vehicle who is involved in vehicular accidents or those defined by the RPC as crimes due to reckless imprudence shall undergo a process of revocation if it cannot present certificate of settlement issued by PNP or MTC/RTC Clearance as the case may be;
5. Tricycle is not registered with LTO;
6. Nonpayment of regulatory fees;
7. Expired franchises not renewed in the reglamentary period;
8. Non-application for MTOP within one (1) year.

**WHEREAS**, the 7<sup>th</sup> City Council, through its Committee on Franchise and the City Tricycle Franchising Regulatory Office, finds the aforesaid Tricycle Franchise holder is in violation Section 20 of City Ordinance No. 22, Series of 2020 otherwise known as the “Sorsogon City New Tricycle Franchise Code of 2020”;

**NOW THEREFORE**, on motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Fernando David H. Duran, III**, resolved as it is hereby resolve to approve the official cancellation/revocation of two (2) Tricycle Franchises as herein identified for violation of Section 20 of City Ordinance No. 22, Series of 2020 otherwise known as the “Sorsogon City New Tricycle Franchise Code of 2020”.

**RESOLVED FURTHER**, that copies of this resolution be furnished to all concerned for their information and guidance.
