**WHEREAS**, records from the Office of the secretary to the Sangguniang Panlungsod revealed that Ms. Annie Diaz, Proprietor, **BEIL GASOLINE** Station has a pending request filed before the Sangguniang Panlungsod seeking for the passage of a resolution interposing no objection on her proposed business endeavor;
