RESOLUTION COMMENDING MR. JOSE ALLAN DIAZ FOR HIS UTMOST COOPERATION IN RELATION TO AFRICAN SWINE FLU (ASF) OCCURRENCE AT PUROK 2, BARANGAY STA. LUCIA, BACON DISTRICT, SORSOGON CITY

WHEREAS, sometime in January 18, 2021, the Regional Animal Disease Diagnostic Laboratory confirmed occurrence of African Swine Flu (ASF) from commercial farm located at Purok 2, Barangay Sta. Lucia, Bacon District, Sorsogon City owned and operated by Mr. Allan Diaz or "BADAS" as his friends and local constituents call him;

WHEREAS, three (3) days prior thereof, Mr. Jose Allan Diaz personally coordinated and informed the City Veterinary Office of cases of swine deaths in his commercial piggery;

WHEREAS, this prompted the City Veterinary Office to instantly conduct inspection and take blood samples of swine therein and was immediately brought to Regional Animal Disease Diagnostic Laboratory in the Department of Agriculture,

Regional Office V wherein results shows African Swine Flu Positive Results and further declaring the said commercial piggery as "Ground Zero";

WHEREAS, the immediate detection through the cooperation of Mr. Jose Allan Diaz and his adherence to the recommendation of the City Government of Sorsogon through the City Veterinary Office resulted to the containment and suppression of African Swine Flu in minimal piggery owners in the said barangay;

WHEREAS, without regards to financial losses, Mr. Jose Allan Diaz also opted not to sell and instead bury the following farm animals to wit;

- 1. 2 boars:
- 2. 10 sows;
- 3. 5 head fattener;
- 4. 23 growers head; and
- 5. 34 piglets

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution commending Mr. Jose Allan Diaz for his utmost cooperation in relation to African Swine Flu (ASF) occurrence at Purok 2, Barangay Sta. Lucia, Bacon District, Sorsogon City;

NOW THEREFORE, on motion of **City Councilor Erwin J. Duana**, duly seconded by **City Councilor Danilo A. Deladia**, resolve as it is hereby resolved to commend Mr. Jose Allan Diaz for his utmost cooperation in relation to African Swine Flu (ASF) occurrence at Purok 2, Barangay Sta. Lucia, Bacon District, Sorsogon City.
