**RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE CIVIL SERVICE COMMISSION REGIONAL OFFICE V (CSC RO V) REPRESENTED BY ATTY. DAISY PUNZALAN BRAGAIS, DIRECTOR IV, RELATIVE TO TWO (2) JOB ORDER EMPLOYEES OF LGU – SORSOGON CITY DETAILED AT THE CSC SORSOGON FIELD OFFICE.**

**WHEREAS**, among the items deliberated during the January 25, 2022 Regular Session of the 7<sup>th</sup> City Council is a letter-request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City, dated January 19, 2022, addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Rovon E. Domasian, SP Secretary, respectfully requesting for the passage of a resolution authorizing her to enter into a Memorandum of Agreement (MOA) with the Civil Service Commission Regional Office V (CSC RO V) represented by Atty. Daisy Punzalan Bragais, Director IV, relative to two (2) job order employees of LGU – Sorsogon City detailed at the CSC Sorsogon Field Office;

**WHEREAS**, the said employees have been detailed therein since the previous fiscal year and has satisfactorily performed the duties assigned unto them at the said agency thus, the CSC requested for the continuance of their services to which LGU acceded;

**WHEREAS**, the CSC is the central personnel agency of the Philippine government tasked to render adjudicative and final arbitration on disputes and human resource actions on civil service matters;

**WHEREAS**, the programs of the CSC are distributed to its Central, Regional and Field and Provincial Offices hence, the CSC Sorsogon Field Office (CSC FO- Sorsogon) is administered/operated by only one (1) Director II and one (1) Senior Human Resource Specialist wherein the number of personnel at CSC FO Sorsogon is insufficient to meet the heavy workload thereat;

**WHEREAS**, to augment the CSC RO V's personnel and provide assistance and services to the latter, the Detailing Office has agreed to detail one (1) of its employees under Contract of Service at CSC FO-Sorsogon;

**WHEREAS**, attached to the letter is a copy of a draft Memorandum of Agreement (MOA) for further perusal of the 7<sup>th</sup> City Council;

**NOW THEREFORE**, on motion of **Hon. Franco Eric O. Ravanilla**, duly seconded by **Hon. Ma. Teresa D. Perdigon** resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Civil Service Commission Regional Office V (CSC RO V) represented by Atty. Daisy Punzalan Bragais, Director IV, relative to two (2) job order employees of LGU – Sorsogon City detailed at the CSC Sorsogon Field Office;
