RESOLUTION RESPECTFULLY REQUESTING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ALLOCATE FUNDS FOR THE CONDUCT OF TWO (2) DAYS ORIENTATION SEMINAR OF THE BUREAU OF FIRE PROTECTION (BFP).

WHEREAS, Republic Act 9514 otherwise known as the “Fire Code of the Philippines of 2008” seeks to ensure public safety, promote economic development through the prevention and suppression of all kinds, of destructive fires, and promote the professionalization of the fire service as a profession and to this end the State shall enforce all laws, rules and regulations to ensure adherence to standard fire prevention and safety measures, and promote accountability in the fire protection and prevention service;

WHEREAS, as a matter of protocol, the Bureau of Fire Protection participates in the annual conduct of Business One Stop Shop (BOSS) wherein the bureau personnel in

the City Fire Station ensures that business establishments complies with the Fire Code Standards;
