RESOLUTION URGING THE HOST BARANGAYS OF THE ENERGY DEVELOPMENT CORPORATION (EDC) GEOTHERMAL OPERATIONS IN WEST AND BACON DISTRICT TO IMMEDIATELY REACTIVATE THE ASSOCIATIONS/ORGANIZATIONS PRIMARILY AIMED AT ADVANCING AND PROTECTING THE BEST INTEREST AND WELFARE OF THEIR CONSTITUENTS.

WHEREAS, in the past, Host Barangays in West and Bacon Districts of Energy Development Corporation operations in Bacon Manito (BACMAN) area are active specially on dealings regarding geothermal operations;

WHEREAS, the privatization of operations of BACMAN Geothermal operations resulted in a more tedious process especially on matter relating to the issue on Royalty Share, Corporate Social Responsibility considering the sudden shift from government to private management supervision;

WHEREAS, in the course of this privatization, host barangays such as Basud, Bucalbucalan, Bulabog, Rizal, Capuy, Ticol in West District and Sto. Nino and Osiao in Bacon District tends to be recently inactive;

WHEREAS, following the issues and concerns being confronted, reactivation of association/organization of host barangays in necessary in order afford host barangays one united stand in addressing pressing issues concerning BACMAN Geothermal operations;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a RESOLUTION REQUESTING THE HOST BARANGAYS OF THE ENERGY DEVELOPMENT CORPORATION (EDC) GEOTHERMAL OPERATIONS IN WEST AND BACON DISTRICT TO IMMEDIATELY REACTIVATE THE ASSOCIATIONS/ORGANIZATIONS PRIMARILY AIMED AT ADVANCING AND PROTECTING THE BEST INTEREST AND WELFARE OF THEIR CONSTITUENTS ;
