RESOLUTION AUTHORIZING THE IMPLEMENTATION OF LOCAL BUDGET CIRCULAR NO. 143 OF THE DEPARTMENT OF BUDGET AND MANAGEMENT FOR THE THIRD TRANCHE OF THE MODIFIED SALARY SCHEDULE FOR LOCAL GOVERNMENT PERSONNEL PURSUANT TO REPUBLIC ACT (RA) NO. 11466

**WHEREAS**, RA No. 114661, otherwise known as the "Salary Standardization Law of 2019" modifies the Salary Schedule for Civilian Personnel and authorizes the grant of additional benefits and shall be implemented in four (4) tranches, i.e., from FY 2020 to FY 2023;

**WHEREAS,** Section 10 of RA No. 11466 stipulates that the modified Salary Schedule under said Act may be granted to personnel of local government units (LGUs), subject to certain conditions;

**WHEREAS**, LBC No. 143 was issued to prescribe the guidelines, rules, and regulations for the implementation of the third tranche of the modified Salary Schedule for Civilian Personnel stipulated under RA No. 11466;

**WHEREAS**, Implementation of the Third Tranche of the Modified Salary Schedule in LGUs Effective January 1, 2022 is subject to the authorization from the Sanggunian concerned, as provided under Sections 447(a), 458(a), and 468(a) of RA 7160;

**NOW THEREFORE,** on motion of the **Hon. Nestor J. Baldon,**, duly seconded by the body, resolve as it is hereby resolved to authorize the implementation of Local Budget Circular No. 143 of the Department of Budget and Management for the third tranche of the modified salary schedule for local government personnel pursuant to Republic Act (RA) No. 11466.
