HAMOR, CITY MAYOR, SORSOGON CITY WITH PRINCESS JAIDEE ENTERPRISES RELATIVE TO THE PURCHASE OF VARIOUS ITEMS FOR PERSONNEL INVOLVED IN THE TULONG PANGHANAPBUHAY SA ATING DISADVANTAGED/ DISPLACED (TUPAD) WORKERS

WHEREAS, among the items deliberated during the February 2, 2022 Regular Session of the 7<sup>th</sup> City Council is a letter-request from Hon. Ma. Ester E. WHEREAS, said project is under the previously perfected Memorandum of Agreement (MOA) with the Department of Labor and Employment (DOLE) Regional Office No. 5 relative to the Tulong Panghanapbuhay Sa Ating Disadvantaged/ Displaced (TUPAD) Workers Program as a post-covid intervention under the Sangguniang Panlungsod Resolution No. 128, Series of 2020;

WHEREAS, the said project is under Contract Reference No. 209-2021-S with Hon. Ma. Ester E. Hamor, City Mayor, City of Sorsogon as the Entity, Jhonie E. Detera, Proprietor, Princess Jaidee Enterprises as the Supplier and the Entity has accepted the Bid for Sixty Six Thousand Seven Hundred Fifty (P66,750.00) Pesos only (hereinafter called the "Contract Price") by the Supplier for the procurement of Tulong Panghanapbuhay For the Tupad Worker;
