RESOLUTION EXPRESSING OBJECTION ON THE WATER PERMIT APPLICATION OF PETER PAUL PHILIPPINE CORPORATION PENDING BEFORE THE NATIONAL WATER RESOURCES BOARD (NWRB).

WHEREAS, among the items deliberated upon by the 7th City Council during the January 18, 2022 Regular Session was the letter from Ms. Evelyn V. Ayson, Officer-In-Charge, Water Right Division, National Water Resources Board (NWRB) requesting that the Notice of Water Permit Application of Peter Paul Philippine Corporation (PPPC) be posted on the Bulletin Board for a period of fifteen (15) days;

WHEREAS, aforementioned letter was officially referred to the Committee on Public Utilities and on January 27, 2022 a Committee hearing was called for the purpose via teleconferencing inviting the presence of Peter Paul Philippine Corporation and Sorsogon City Water District Representatives;

WHEREAS, the invitation of Sorsogon City Water District representatives is vital bearing in mind that parties herein mentioned are crucial personalities on water utility operations in the City of Sorsogon;

WHEREAS, discussion thereof reflects that Sorsogon City Water District through their respective representatives officially registered doubt and hostility as regards to the herein mentioned Water Permit Application of Peter Paul Philippine Corporation (PPPC) following the much experienced scarcity of water in the locality;

WHEREAS, a proposal was discussed wherein PPPC's excess water generation shall be diverted to Sorsogon City Water District helping address the present water scarcity, parties also agreed to bring the matter to the attention of their respective top management and status report shall be available fifteen (15) days thereafter;

WHEREAS, on February 1, 2022, Engr. Eduardo Tejada wrote a letter addressed to the Hon. Ravanilla manifesting that Sorsogon City Water District is adversely affected by the deep well operations of PPPC, unless parties arrive at an agreement which would be beneficial and acceptable to all water consumers, thus this resolution;

NOW THEREFORE, on incidental motion of the **Hon. Franco Eric O. Ravanilla** duly seconded by the **Hon. Lorenz S. Abenion**, resolve as it is hereby resolved to express objection on the Water Permit Application of Peter Paul Philippine Corporation pending before the National Water Resources Board (NWRB);


RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and guidance.
