RESOLUTION IMPLEMENTING CITY ORDINANCE NO. 024, SERIES OF 2021 DATED NOVEMBER 16, 2021 ENTITLED “AN ORDINANCE AMENDING CITY ORDINANCE NO. 06, SERIES OF 2021 THEREBY PRESCRIBING A NEW EMERGENCY PROVISIONAL FARE MATRIX FOR TRICYCLE FOR HIRE AMID COVID 19 AND PROVIDING PENALTIES FOR VIOLATION THEREOF”.

WHEREAS, following the onset of COVID 19 Pandemic, the 7th City Council tediously work on enacting legislations focused on protecting the interest of the general constituents especially when the local economic situation is greatly devastated;

WHEREAS, among those greatly affected is the tricycle transport sector wherein as per record of the Sangguniang Panlungsod, the 7th City Council has enacted and approved several legislations focused on protecting the interest of the tricycle transport sector and the general riding public as well;

WHEREAS, in order for our economy roll, movement of persons especially those in the working class should be permitted subject to certain restrictions as determined by the Inter Agency Task Force;

WHEREAS, following the preceding statement, the tricycle transport sector, being the usual mode of transportation of the general riding public plays a vital role in conveying passengers from and to their respective residences and work place;

WHEREAS, foregoing premise considered, the 7th City Council deemed it necessary to pass a resolution implementing City Ordinance No. 024, series of 2021 dated November 16, 2021 entitled "An Ordinance amending City Ordinance No. 06, series of 2021 thereby prescribing a New Emergency Provisional Fare Matrix for Tricycle For Hire amid COVID 19 and providing penalties for violation thereof".
