RESOLUTION APPROVING THE REQUEST FOR ACCREDITATION OF CABID-AN WOMEN'S LIVELIHOOD ORGANIZATION (CWLO) BY THE SANGGUNIANG PANLUNGSOD.

WHEREAS, among the items deliberated during the February 22, 2022 Regular Session of the 7th City Council is a letter-request from Ms. Gemma L. Despabiladeras, President, CWLO addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor, requesting for accreditation of Cabid-an Women's Livelihood Organization (CWLO) by the City Council;

WHEREAS, Cabid-an Women's Livelihood Organization (CWLO) has applied for accreditation at the Sangguniang Panlungsod Sorsogon City pursuant to Memorandum Circular No. 2007-89 dated February 1, 2011 of the Department of the Interior and Local Government (DILG);

WHEREAS, the criteria for accreditation as embodied in the Memorandum Circular No. 2007-89 of the DILG was substantially complied by the association;

WHEREAS, after careful scrutiny of the documents submitted by the applicant, the Committee on Livelihood, Cooperatives, PO's, GO's and NGO's found it sufficient and thus recommends for its approval;

WHEREAS, it is the duty of the Local Government Unit to develop the potentials and capabilities of people by providing support on their venture towards enhancing their economic and social well-being;
