RESOLUTION URGING THE CITY HEALTH OFFICE (LOCAL INTER AGENCY TASK FORCE) TO RECOMMEND THE IMPLEMENTATION OF A NEW CURFEW HOURS FROM 12:00 MIDNIGHT TO 4:00 IN THE MORNING OF THE NEXT DAY IN THE TERRITORIAL JURISDICTION OF THE CITY OF SORSOGON.

WHEREAS, in consonance with guidelines imposed the National Inter Agency Task Force, local government units implement curfew hours in order to regulate people's mobility to essential purposes;

WHEREAS, for more than three (3) years already, business establishments operating at night were greatly devastated in view of the restrictions imposed upon by authorities and the implementation of Curfew Hours;

WHEREAS, on February 14, 2022, the National Inter Agency Task Force released Resolution No. 161, series of 2022 declaring Sorsogon among others under Level 2;

WHEREAS, cognizant of the plight of business establishments operating at night, there is a need to implement a New Curfew Hours in the territorial jurisdiction of the City of Sorsogon;

NOW THEREFORE, on motion of **City Councilor Franco Eric O. Ravanilla** duly seconded by **City Councilor Danilo A. Deladia** resolve as it is hereby resolved to urge the City Health Office (Local Inter Agency Task Force) to recommend the implementation of a New Curfew Hours from 12:00 Midnight to 4:00 in the morning of the next day in the territorial jurisdiction of the City of Sorsogon;
