RESOLUTION RESPECTFULLY REQUESTING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO AUTHORIZE THE OPENING OF SPORTS FACILITIES AND TO ALLOW SPORTS ACTIVITIES IN THE BARANGAYS WITH ZERO CASE OF COVID 19 IN CONSONANCE WITH SECTION 1 (2) (m) OF EXECUTIVE ORDER NO. 07, SERIES OF 2021 DECLARING MODIFIED SAFETY PROTOCOL IN THE CITY OF SORSOGON BEING UNDER ALERT LEVEL 2

WHEREAS, the state recognizes the vital role of the youth in the nation-building, thus, the Constitution mandates the promotion of their physical, moral, spiritual, intellectual and social being;

WHEREAS, the state further mandates the formulation, adoption and implementation of an integrated and coordinated youth development program which is responsive to the needs and involvement of the youth in the affairs of the state;

WHEREAS, Article XIV, Section 19 (1) of the 1987 Constitution provides that “The State shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork and excellence for the development of a healthy and alert citizenry”;

WHEREAS, the Hon. City Mayor Ma. Ester E. Hamor in its Executive Order No. 7-2022, particularly Section 1 (2)(m) thereof authorizes the conduct of contact sports as approved by the LGU where such games shall be held;

WHEREAS, opening of sports facilities and allowing sports activities in the barangays with zero case of Covid 19 is hereby authorized with the following suggestions:

1. Sports facilities in the barangays shall be opened from 5am to 5pm.
2. Use of sports facilities and sports activities in the barangays shall only be allowed to vaccinated individuals.
3. Strict observance to the minimum health standards/protocols.
4. Regular conduct of disinfections to sports facilities and venue of activities.
5. No players shall be allowed to use any sports facilities in the barangay, unless a prior notice is given for proper planning and scheduling.
6. Participants in the scheduled sports activities in the barangay shall be required submit themselves for temperature check and to deposit vaccination card for recording which shall be returned after the game.
7. Sports tournament shall be allowed only to vaccinated players and officiating committee.
8. Strict prohibition on game fixing and betting.

NOW THEREFORE, on motion of Hon. Lorenz S. Abenion, duly seconded by **Hon. Danilo A. Deladia**, resolved as it is hereby resolve to respectfully request Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to authorize the opening of sports facilities and to allow sports activities in the barangays with zero case of Covid 19 in consonance with Section 1 (2) (m) of Executive Order No. 07, Series of 2021 declaring modified safety protocol in the city of Sorsogon being under Alert Level 2.
