RESOLUTION RECOGNIZING MR. LAURENTE MADRONIO MARINDA OF BARANGAY BIBINCAHAN, EAST DISTRICT, SORSOGON CITY, FOR HIS HISTORICAL ACHIEVEMENT AND CONTRIBUTION TO OUR LOCAL LITERATURE AND CULTURE WITH THE PUBLICATION OF HIS EPIC, Redentor de Amor, THROUGH THE COMPETITIVE GRANT OF THE BOARD OF COMMISSIONERS OF THE NATIONAL COMMISSION ON CULTURE AND THE ARTS (NCCA)

**WHEREAS**, the 7<sup>th</sup> City Council, through the Committee on Education, Arts, Culture and Heritage, joins Mr. Laurente Madronio Marinda in blissfully celebrating his achievement with the publication of his Epic, Redentor de Amor, originally titled, Nogosros.

**WHEREAS,** it is known to the 7<sup>th</sup> City Council, that this Epic is a colossal achievement characterizing, at the same time, the protracted, careful and epochal creation of this obra maestra displaying the creativity of then young Mr. Marinda until 50 years after embodying the formation of his wisdom in such epic.

**WHEREAS,** he now joins the collective of Sorsoganon artists who helped in the strengthening of every foundation of Filipino art and literature.

**WHEREAS**, the Local Government Code of 1991 (LGC) provides that Sorsogon City shall "[e]stablish a city council whose purpose is the promotion of culture and the arts, coordinate with government agencies and non-governmental organizations, and subject to the availability of funds, appropriate funds for the support and development of the same."

**WHEREAS**, the formal book launching of the Epic is on April 22, 2022 in Sorsogon City. This shall be actively coordinated by the City Government in accordance with the communication sent by the NCCA to Mr. Marinda.

**WHEREAS,** the 7<sup>th</sup> City Council urges the Executive Department through the Office of Tourism, Culture and the Arts to coordinate with Mr. Marinda and the NCCA in this epoch-making publication; as well as to allocate funds for the purpose of book launching and a counter-part fund for the purpose of publication and financial grant to Mr. Marinda.

**WHEREAS**, the 7<sup>th</sup> City Council, in accordance with LGC, shall appropriate necessary funds if there are no allocation yet for the purpose.

**NOW THEREFORE**, on motion of **Hon. Joven Francis J. Laura**, duly seconded by **Hon. Danilo A. Deladia**, resolved as it is hereby resolve to recognize Mr. Laurente Madronio Marinda of Barangay Bibincahan, East District, Sorsogon City, for his historical achievement and contribution to our local literature and culture with the publication of his epic, Redentor de Amor, through the competitive grant of the Board of Commissioners of the National Commission on Culture and the Arts (NCCA).
