RESOLUTION ADOPTING EXECUTIVE ORDER NO. 07, SERIES OF 2022 OF HON. CITY MAYOR MA. ESTER E. HAMOR – AN ORDER DECLARING MODIFIED SAFETY PROTOCOLS CONSONANT WITH THE IATF GUIDELINES FOR AREAS UNDER ALERT LEVEL 2 IN THE CITY OF SORSOGON

WHEREAS, the 7th City Council was in receipt of the Executive order No. 07, Series of 2022 of Hon. City Mayor Ma. Ester E. Hamor – An order declaring modified safety protocols consonant with the IATF Guidelines for areas under Alert Level 2 in the City of Sorsogon;

WHEREAS, Executive Order No. 151 issued by the President on November 11, 2021 approved the nationwide implementation of the Alert Level System for Covid 19 response recommended by the Inter-Agency task force for the Management of Emerging Infectious Diseases (IATF);

WHEREAS, IATF Resolution No. 157A placed the Province of Sorsogon, among other provinces, HUCs and ICCs, under Alert Level 3 following the surge in the number of Covid 19 cases effective January 16, 2022 until January 31, 2022;

WHEREAS, IATF Resolution No. 159A approving the recommendation of the sub-Technical Working Group on Data Analytics, classified the province under the same Alert Level 3 to Alert Level 2 from February 1, 2022 to February 15, 2022;

WHEREAS, IATF Resolution No. 161A downgraded the classification of the Province of Sorsogon from Alert Level 3 to Alert Level 2 from February 16 to 22, 2022

WHEREAS, Executive Order No. 07, Series of 2022 of Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City provides protocols which shall be observed in areas under Alert Level 2, except for portions thereof under granular lockdown;

WHEREAS, the EO further provides public health standards and vaccination protocols and its strict enforcement thereof;

NOW THEREFORE, on motion of **Hon. Franco Eric O. Ravanilla**, duly seconded by **Hon. Joven Francis J. Laura**, resolved as it is hereby resolve to adopt Executive Order No. 07, Series of 2022 of Hon. Ma. Ester E. Hamor – An order declaring modified safety protocols consonant with the IATF guidelines for areas under alert level 2 in the City of Sorsogon.
