HAMOR, CITY MAYOR, SORSOGON CITY TO PROVIDE ALL KIND OF ASSISTANCE TO ALL PUBLIC AND PRIVATE SCHOOLS IN THE CITY OF SORSOGON IN THEIR PREPARATION FOR THE TRADITIONAL FACE TO FACE CLASSES UNDER THE NEW NORMAL ARRANGEMENTS**

**WHEREAS**, the city government of Sorsogon City had been in numerous account entered into a Memorandum of Agreement with different schools for the use of school rooms and campuses as temporary quarantine facilities particularly during the surge of Covid 19 cases in the city jurisdiction;
