RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH VARIOUS SCHOOLS RELATIVE TO THE CONDUCT OF WORK IMMERSION/PRACTICUM/ON-THE-JOB TRAINING (OJT) IN THE CITY GOVERNMENT OF SORSOGON.

WHEREAS, among the items deliberated during the March 01, 2022 Regular Session of the 7th City Council is a letter-request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City dated February 23, 2022 with attached copy of the draft Memorandum of Agreement (MOA), addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the Sangguniang Panlungsod thru Mr. Rovon E. Domasian, Secretary to the SP, respectfully requesting for the passage of a Resolution authorizing her to enter into a Memorandum of Agreement (MOA) with various schools relative to the conduct of Work Immersion/Practicum/On-the-Job Training (OJT) in the City Government of Sorsogon;

WHEREAS, as the number of positive COVID-19 cases continue to decline, the education sector has begun to open doors for the continuing education of the youth and schools and universities started processing their shift from modular and online learning to the limited face to face modality as we prepare our entry to the new normal;
