RESOLUTION ENDORSING THE REQUEST OF THE SORSOGON CITY PNP TO CPNP PGEN DIONARDO BERNARDO CARLOS FOR TWO (2) UNITS OF PATROL JEEP TOYOTA HI-LUX DOUBLE CAB INTENDED FOR USE FOR PROGRAMS ON PEACE AND SECURITY IN THE CITY OF SORSOGON.

WHEREAS, among the items deliberated during the March 01, 2022 Regular Session of the 7th City Council is a letter from the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City dated February 23, 2022 addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the Sangguniang Panlungsod thru Mr. Rovan E. Domasian, SP Secretary requesting for the passage of a Resolution endorsing the request of the Sorsogon City PNP to CPNP PGEN Dionardo Bernardo Carlos for two (2) units of Patrol Jeep Toyota Hi-Lux double cab intended for use for programs on peace and security in the City of Sorsogon.

WHEREAS, the Sorsogon City PNP is one of the strongest partners in the implementation of programs relative to the peace and order of the community thus LGU provided the local police force with patrol cars that they are currently using for monitoring and response;

WHEREAS, LGU Sorsogon City understands that Sorsogon City PNP requires a sizeable number of vehicles for especially for their operations, considering that the City of Sorsogon is comprised of Sixty Four (64) barangays and as such LGU Sorsogon City highly supports their efforts to acquire additional vehicles which can be used for the local programs on security;
