RESOLUTION ENDORSING TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) AND THE REGIONAL DEVELOPMENT COUNCIL (RDC) THE PROPOSED CONSTRUCTION OF A NEW BUILDING OF THE PHILIPPINE STATISTICS AUTHORITY (PSA) SORSOGON PROVINCIAL OFFICE WITHIN THE CITY OF SORSOGON

WHEREAS, on February 18, 2022 the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Members of the 7th City Council requesting for the passage of appropriate Sangguniang Panlungsod Resolution in relation to the request for endorsement to the Department of Budget and Management (DBM) and Regional Development Council (RDC) the proposed construction of a new building of the Philippine Statistics Authority (PSA) Sorsogon Provincial Office within the City of Sorsogon thru a Sangguniang Panlungsod resolution;

WHEREAS, such letter request of the local chief executive was among the items deliberated upon by the 7th City Council during the March 1, 2022 Regular Session;

WHEREAS, said document is among the pre-requisites of the Regional Development Council (RDC) for the issuance of an endorsement to the Department of Budget and Management (DBM) as the funding for the construction of the edifice and shall be charged under the 2023 budget of the Philippine Statistics Authority (PSA);

WHEREAS, the Philippine Statistics Authority (PSA) is one of the agencies which has implementing programs highly beneficial to the people of Sorsogon City;

WHEREAS, foregoing premise considered and after due deliberation on the matter the 7th City Council deemed it necessary to pass a resolution endorsing to the Department of Budget and Management (DBM) and Regional Development Council (RDC) the proposed construction of a new building of the Philippine Statistics Authority (PSA) Sorsogon Provincial Office within the City of Sorsogon;

Now therefore, on motion of **City Councilor Nestor J. Baldon** duly seconded by the **City Councilor Joven Francis J. Laura**, resolve as it is hereby resolved to endorse to the Department of Budget and Management (DBM) and Regional Development Council (RDC) the proposed construction of a new building of the Philippine Statistics Authority (PSA) Sorsogon Provincial Office within the City of Sorsogon;
