RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MOBILE PAYMENT SOLUTION AGREEMENT WITH G-EXCHANGE, INC. REPRESENTED BY MR. JOSE LUIS G. REYES, VICE PRESIDENT AND ENTERPRISE GROUP HEAD RELATIVE TO THE LOCAL ON LINE PAYMENT SCHEME.

WHEREAS, on January 26, 2022, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to the Hon. Mark Eric C.
