RESOLUTION URGING ENGR. HENDRICKSON LATONIO, BRANCH MANAGER, PRIME WATER INFRASTRUCTURE CORPORATION, SORSOGON CITY TO TAKE JUDICIOUS ACTION ON THE UNFINISHED PROJECTS WITHIN THE TERRITORIAL JURISDICTION OF SORSOGON CITY.

WHEREAS, among the reasons presented by Prime Water Infrastructure Corporation, Sorsogon City in the poor water service to water consumers is the infrastructure inputs being undertaken;

WHEREAS, at present, several infrastructure projects implemented by Prime Water Infrastructure Corporation remains unfinished posing threat to road users and obstruct traffic flow;

WHEREAS, for purposes of this resolution, hereunder are places wherein pipe laying activities were initiated by Prime Water Infrastructure Corporation which remain unfinished as follows;

1. Magsaysay Street near Annunciation College, Barangay Bibincahan, East District, Sorsogon City;
2. Magsaysay Street, Barangay Bibincahan, East District, in front of Celand's Place;
3. Magsaysay Street, Barangay Bibincahan, East District, Sorsogon City;
4. J. Reyes Street, Barangay Talisay, West District, Sorsogon City near Sorsogon Pilot Elementary School;
5. T. Dino Maharlika Highway, Barangay Balogo, East District, Sorsogon City;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution urging Engr. Hendrickson Latonio, Branch Manager, Prime Water Infrastructure Corporation, Sorsogon City to take judicious action on the unfinished projects within the territorial jurisdiction of Sorsogon City;

NOW THEREFORE, on incidental motion of **City Councilor Franco Eric O. Ravanilla** duly seconded by the body, resolve as it is hereby resolved to urge Engr. Hendrickson Latonio, Branch Manager, Prime Water Infrastructure Corporation, Sorsogon City to take judicious action on the unfinished projects within the territorial jurisdiction of Sorsogon City;

RESOLVED FURTHER, hat the continuous frustrating display of inaction and incompetence of Prime Water Infrastructure Corporation, Sorsogon City in line with their mandate would lead to a graver dissatisfaction and complete distrust among water consumers and stakeholders;
