RESOLUTION RESPECTFULLY APPEALING THE BARANGAY COUNCIL OF THE 64 BARANGAYS OF SORSOGON CITY TO IMMEDIATELY RELEASE THE 10% SK FUND ON MONTHLY BASIS UPON RECEIPT OF THE INTERNAL REVENUE ALLOTMENT (IRA) OF THE BARANGAY

WHEREAS, the Internal Revenue Allotment (IRA) is the annual share of local government out of the proceeds from national internal revenue taxes which was estimated at forty (40) percent of the actual collections of national internal revenue taxes during the third fiscal year preceding the current year, as certified by the Bureau of Internal Revenue (BIR);

WHEREAS, the IRA is automatically released to each local government unit and may not be held back by the national government for any reason, except in the extreme case of an “unmanageable public sector deficit”;

WHEREAS, Department of Budget and Management (DBM), Department of the Interior and Local Government (DILG) and National Youth Commission (NYC) issued Joint Memorandum Circular (JMC) No. 1, series of 2019 that sets the Guidelines on the Appropriation, Release, Planning and Budgeting Process for the SK Funds, emphasizing on the concomitant posting requirements to enhance transparency and accountability;

WHEREAS, DBM, DILG and NYC Joint Memorandum Circular No. 1, s. 2019 dated January 23, 2019, states that upon receipt of the monthly internal revenue allotment (IRA) of the barangay, the Punong Barangay shall automatically release not later than five (5) working days without further delay the ten percent (10%) of the barangay’s general fund as share of the Sangguniang Kabataan or youth council;

WHEREAS, this measure aims to provide guarantee or assurance that budget allocation for SK is religiously and promptly released so as not to delay the implementation of the Programs, Projects and Activities of the SK of the 64 barangays in the City of Sorsogon;

NOW THEREFORE, on motion of **Hon. Joven Francis J. Laura** duly seconded by **Hon. Erwin J. Duana** resolve as it is hereby resolved to respectfully appeal the Barangay Council of the 64 barangays of Sorsogon City to immediately release the 10% SK fund on monthly basis upon receipt of the internal revenue allotment (IRA) of the barangay.
