RESOLUTION RESPECTFULLY REQUESTING THE LIGA NG MGA BARANGAY AND THE BARANGAY COUNCILS IN THE CITY OF SORSOGON TO CONDUCT AN INFORMATION DISSEMINATION AND PRECAUTIONARY MEASURES AGAINST THE PRESENCE OF STRAY DOGS DURING THE CONDUCT OF MOTO AD 2022 SUMMER EDITION WHICH WILL BE HELD ON MARCH 20, 2022 TO AVOID ACCIDENTS AND TO ENSURE ROAD SAFETY THEREIN

WHEREAS, Moto Ad (Adventure) 2022 Summer Edition is a provincial event sponsored by the Provincial Government of Sorsogon to be participated by motorcycle enthusiasts from all over the country;

WHEREAS, the itinerary of the event and the journey of the participants will start from the City of Sorsogon and to cover almost of the municipalities in the province;

WHEREAS, a massive information dissemination and precautionary measures against the presence of stray dogs during the conduct of Moto Ad 2022 Summer Edition would ensure road safety to the participants and to the general viewing public during the event;

WHEREAS, the measure would like to ensure that the motor accident in the province of Leyte will not happen in the City of Sorsogon, wherein during the conduct of the same event, an stray dog suddenly passed the main street and thereby collided with the participant/s, causing serious and fatal injuries;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitants;

NOW THEREFORE, on motion of **Hon. Jo Abegail C. Dioneda**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolved as it is hereby resolve to respectfully request the Liga ng mga Barangay and the Barangay Councils in the City of Sorsogon to conduct an information dissemination and precautionary measures against the presence of stray dogs during the conduct of Moto Ad 2022 Summer Edition which will be held on March 20, 2022 to avoid accidents and to ensure road safety therein.
