RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION OF MS. CHANDA GRETCHEN A. DIONEDA FOR THE OPERATION OF E-SABONG IN THE TERRITORIAL JURISDICTION OF THE CITY OF SORSOGON SUBJECT TO COMPLIANCE OF APPROPRIATE DOCUMENTATION AND REQUIREMENTS.

WHEREAS, following the issuance of E-Sabong licenses to several corporations by PAGCOR, local interested business enthusiast filed their respective applications before the Sangguniang Panlungsod;

WHEREAS, one of the items deliberated upon by the 7th City Council on its March 15, 2022 Regular Session was the letter of Ms. Chanda Gretchen A. Dioneda requesting for a passage of a

resolution interposing no objection to engage and operate an online sabong in the territorial jurisdiction of the City of Sorsogon;

WHEREAS, considering the various applications filed before the Sangguniang Panlungsod, the Committee on Games and Amusement made it a point to be cautious especially when E-Sabong was just recently introduced;

WHEREAS, following the information shared before the committee by Mr. Rodel Ferreras, the committee decided to recommend for the following;

1. The passage of a resolution interposing no objection on various applications for E-Sabong pending before the Sangguniang Panlungsod provided that applicants shall adhere and comply with requirements imposed upon by PAGCOR and other government entities;
2. That all documents submitted before the legislative department in relation to the herein mentioned E-Sabong applications be submitted to the Office of the City Mayor through the Permits and Licenses Section;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution interposing no objection to the application of Ms. Chanda Gretchen A. Dioneda for the of E-sabong in the territorial jurisdiction of the City of Sorsogon subject to compliance of appropriate documentation and requirements

NOW THEREFORE, on motion of **City Councilor Danilo A. Deladia**, duly seconded by **City Councilor Fernando David H. Duran, III**, resolve as it is hereby resolved to interposing no objection to the application of Ms. Chanda Gretchen A. Dioneda for the operation of E-sabong in the territorial jurisdiction of the City of Sorsogon subject to compliance of appropriate documentation and requirements.

RESOLVED FINALLY, that the Secretary to the Sangguniang Panlungsod transmit to the Office of the City Mayor through the Permit in Licenses Section documents relevant to E-Sabong of the herein mentioned applicant or their perusal and appropriate action.
