RESOLUTION MOST RESPECTFULLY REQUESTING THE CITY TREASURER'S OFFICE- CITY GOVERNMENT OF SORSOGON TO IMMEDIATELY RE-CONDUCT INSPECTION AND INITIATE UNANNOUNCED CALIBRATION OF DISPENSING PUMPS METERS OF ALL GASOLINE STATIONS WITHIN THE TERRITORIAL JURISDICTION OF SORSOGON CITY

**WHEREAS,** It is the mandate of the City Government of Sorsogon through the City Treasurer's Office to protect the interest of every consumers against fraudulent gasoline dispensing activities;

**WHEREAS,** following the recent unprecedented gasoline price hike, consumers find difficulties in coping up with the present scenario aggravated by fraudulent gasoline dispensing practices by some gasoline stations;

**WHEREAS**, unannounced calibration of gasoline pumping stations is also necessary in order to ensure that dispensation of gasoline products is accurate and precise;

**WHEREAS,** foregoing premises considered, the 7<sup>Th</sup> City Council deemed it necessary to pass a resolution most respectfully requesting the City Treasurer's Office to immediately reconduct inspection and initiate unannounced calibration of dispensing pump meters of all gasoline stations within the territorial jurisdiction of Sorsogon City;

**NOW THEREFORE** on motion of **Hon. Erwin J. Duana** duly seconded by Hon. Danilo A. Deladia, resolved as it is hereby resolve to respectfully request the City Treasurer's Office to immediately re-conduct inspection and initiate unannounced calibration of dispensing pump meters of all gasoline stations within the territorial jurisdiction of Sorsogon City;
