RESOLUTION ISSUING TRICYCLE FRANCHISE TO FOUR (4) QUALIFIED WAITING APPLICANTS FROM PREVIOUSLY CANCELLED/REVOKED TRICYCLE FRANCHISES UNDER SP RESOLUTION NO. 052, SERIES OF 2022 IN ACCORDANCE WITH CITY ORDINANCE NO. 22, SERIES OF 2020 OTHERWISE KNOWN AS THE “SORSOGON CITY NEW TRICYCLE FRANCHISE CODE OF 2020”

WHEREAS, SP Resolution No.052, Series of 2022, approved on February 8, 2022 officially cancelled and revoked tricycle franchises in favor of the City Government of Sorsogon, in accordance with City Ordinance No. 22, Series of 2020 otherwise known as the “Sorsogon City New Tricycle Franchise Code of 2020”;

WHEREAS, on February 8, 2022, the Tricycle Franchising Regulatory Office through the SP Committee on Tricycle Franchise endorsed the four (4) qualified waiting applicants for the aforesaid cancelled/revoked tricycle franchises, to wit:

1. **Tricycle Franchise No. 1981/Tricycle Franchise Plate No. 1981** awarded in the name of **JOEL L. AGUSTIN** of Pangpang W.. D. Sorsogon District, Sorsogon City, with the route covered by PVTAS
2. **Tricycle Franchise No. 2771/Tricycle Franchise Plate No. 2771** awarded in the name of **MICHAEL JOHN B. DRUE** of San. Roque, B. D. Sorsogon District, Sorsogon City, with the route covered by SCIKWA.
3. **Tricycle Franchise No. 3343/Tricycle Franchise Plate No. 3343** awarded in the name of **EARL CARLO P. GACIAS** of Sampaloc E. D. Sorsogon District, Sorsogon City, with the route covered by SCIKWA.
4. **Tricycle Franchise No. 1504/Tricycle Franchise Plate No. 1504** awarded in the name of **DENNIS D. DURAN V** of Bibicanhan, E. D. Sorsogon District, Sorsogon City, with the route covered by SUBTRODA.

WHEREAS, Section 14 of City Ordinance No. 22-2020 (“Sorsogon City New Tricycle Franchise Code of 2020”) provides that The Sangguniang Panlungsod shall issue/grant franchise to operate a motorized tricycle for hire to qualified persons who desire to provide transport service to the general public by means of a motorized tricycle for monetary consideration. Being a privilege, it can be revoked, cancelled or withdrawn unilaterally at any time upon reasonable grounds;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Ralph Walter R. Lubiano**, resolved as it is hereby resolve to issue tricycle franchise to four (4) qualified waiting applicants from previously cancelled/revoked tricycle franchises under SP Resolution No. 052, Series of 2022 in accordance with City Ordinance No. 22, Series of 2020 otherwise known as the “Sorsogon City New Tricycle Franchise Code of 2020”.
