RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE STATISTICS AUTHORITY (PSA) REPRESENTED BY ITS REGIONAL DIRECTOR, CYNTHIA L. PERDIZ, CESO V, RELATIVE TO THE IMPLEMENTATION OF THE BIRTH REGISTRATION PROJECT IN THE CITY OF SORSOGON.

WHEREAS, among the items deliberated during the March 22, 2022 Regular Session of the 7<sup>th</sup> City Council is a letter-request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City, dated March 17, 2022, addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Rovan E. Domasian, SP Secretary, respectfully requesting for the passage of a resolution authorizing her to enter into a Memorandum of

Agreement (MOA) with the Philippine Statistics Authority (PSA) represented by its Regional Director, Cynthia L. Perdiz, CESO V, relative to the implementation of the Birth Registration Project in the City of Sorsogon;

**WHEREAS**, the said project is among the major programs of the PSA with the end view of ensuring that all Filipinos are registered in the Local Civil Registry and the PhilSys National Identification System which shall also provide an avenue for the citizens of the country to claim their social benefits and legal identity;

WHEREAS, the PSA is headed by the National Statistician and Civil Registrar General as provided under Republic Act No. 10625 and its Implementing Rules and Regulations and under Rule 11 Article (c) of the IRR of RA 10625, it states that the National Statistician who is also the Civil Registrar General shall provide overall direction in the implementation of the Civil Registry Law related issuances and exercise technical supervision over the civil registrars;

**WHEREAS,** the proposed project entitled "PhilID Registration Assistance Project for the Municipality of Sorsogon City" aims to increase civil registration in marginalized communities, particularly those belonging to the Indigenous Peoples (IP) and the poorest sector;

**WHEREAS,** the City Mayor have manifested their cooperation by allowing the conduct of Mobile Registration in the Municipality of Sorsogon City, Sorsogon to provide services to its constituents;

WHEREAS, the PSA in collaboration with the Department of the Interior and Local Government (DILG) and the Local Government Units through the Municipality Government of Sorsogon City principally aim to register those unregistered births aligned with the creation of a single identity card for all Filipinos pursuant to the Philippine Identification System Act (Republic Act No. 11055);

**WHEREAS**, attached to the letter is a copy of a draft Memorandum of Agreement (MOA) for further perusal of the  $7^{th}$  City Council;

**NOW THEREFORE,** on incidental motion of **Hon. Rebecca D. Aquino,** duly seconded by **Hon. Danilo A. Deladia** resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Philippine Statistics Authority (PSA) represented by its Regional Director, Cynthia L. Perdiz, CESO V, relative to the implementation of the Birth Registration Project in the City of Sorsogon;
