RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE JARDIN DE MARIA (SOMASCAN MISSIONARY SISTERS) FOUNDATION INC., REPRESENTED BY SR. SHIRLY E. ENTERIA, MS ADMINISTRATOR, RELATIVE TO THE GRANT OF FINANCIAL ASSISTANCE FROM THE CITY GOVERNMENT OF SORSOGON.

WHEREAS, among the items deliberated during the March 22, 2022 Regular Session of the 7<sup>th</sup> City Council is a letter-request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City, dated March 17, 2022, addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Rovan E. Domasian, SP Secretary, respectfully requesting for the passage of a resolution authorizing her to enter into a Memorandum of

Agreement (MOA) with the Jardin De Maria (Somascan Missionary Sisters) Foundation Inc., represented by Sr. Shirly E. Enteria, MS Administrator, relative to the grant of financial assistance from the City Government of Sorsogon;

**WHEREAS**, the Local Government Unit of the City of Sorsogon has continually provided support to various organizations that offer care to residents of the city and among which is the Jardin De Maria (Somascan Missionary Sisters) Foundation Inc. which caters to economically poor children;

WHEREAS, LGU Sorsogon City assures the necessary annual counterpart of Two Hundred Thousand (P200,000.00) Pesos in which will be used for education (tuition fee, books and miscellaneous), food, clothing, toiletries and shelter, medical and dental treatment intended to all in housed clients of the Jardin De Maria (Somascan Missionary Sisters) Foundation Inc. and will cooperate, abide and will be flexible to the guidelines and operating procedures mandated by the Office of the Mayor corresponding and within the context of the Commission on Audit (COA) Rulings;

**WHEREAS,** Jardin De Maria Foundation Inc. will allow the City Government to conduct monitoring inspection and project implementation corresponding only to the fund subsidized by the City Government;

**WHEREAS**, attached to the letter is a copy of a draft Memorandum of Agreement (MOA) for further perusal of the 7<sup>th</sup> City Council;

**NOW THEREFORE,** on incidental motion of **Hon. Rebecca D. Aquino,** duly seconded by **Hon. Franco Eric O. Ravanilla** resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Jardin De Maria (Somascan Missionary Sisters) Foundation Inc., represented by Sr. Shirly E. Enteria, MS Administrator, relative to the grant of financial assistance from the City Government of Sorsogon;
