RESOLUTION RESPECTFULLY REQUESTING DR. ROLANDO DEALCA, OIC CITY HEALTH OFFICER TO CONDUCT IMMEDIATE ON SITE MEDICAL ASSESSMENT AND MONITORING IN RELATION TO THE ALLEGED DIARRHEA AND VOMITING CASES AT PINACULAN ISLAND, BARANGAY BITAN-O, WEST DISTRICT, SORSOGON CITY .

WHEREAS, health and general welfare of children is of outmost concern being one of the most vulnerable against diseases;

WHEREAS, the Office of the City Vice Mayor received reports of alleged Diarrhea and vomiting cases in Barangay Bitan-o, West District, Sorsogon City specifically in Pinaculan Island;

WHEREAS, Mrs. Lily D. Lesano, Barangay Health Worker in Barangay Bitan-o, West District when asked also confirmed that Diarrhea and vomiting cases were reported in the area;

WHEREAS, in order to protect our children from health risks attributed by Diarrhea and Vomiting, there is a need to immediately conduct an On Site Medical Assessment and Monitoring and to introduce mitigating health endeavors as the need arises;

NOW THEREFORE, on motion **Hon. Rebecca D. Aquino**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolve as it is hereby resolved to respectfully request Dr. Rolando Dealca, OIC City Health Officer to conduct immediate On Site Medical Assessment and Monitoring in relation to the alleged Diarrhea and vomiting cases at Pinaculan Island, Barangay Bitan-o, West District, Sorsogon City;
