ESCUDERO, GOVERNOR, PROVINCE OF SORSOGON, ALL MUNICIPAL MAYORS, CITY MAYOR OF SORSOGON AND ALL FRONTLINERS PAVING WAY TO A ZERO COVID 19 CASE IN THE TERRITORIAL JURISDICTION OF THE PROVINCE OF SORSOGON.**

**WHEREAS**, COVID 19 Pandemic overwhelmingly affected global economy and locally experienced by local government units;
