**RESOLUTION APPROVING AND AUTHORIZING THE CONDUCT OF ENCONTRADA ON APRIL 12, 13, AND 14, 2022 SPONSORED BY SENIOR CITIZEN ASSOCIATION OF BARANGAY GUINLAJON, WEST DISTRICT, SORSOGON CITY AT SORSOGON COCKPIT COLISEUM, BRGY. BIBINCAHAN, EAST DISTRICT, SORSOGON CITY**

**WHEREAS**, among the items deliberated during the March 22, 2022 Regular Session of the 7th City Council was the Letter from the Senior Citizen Association of Brgy. Guinlajon, West District, Sorsogon City requesting for a passage of a resolution authorizing and approving the conduct of *encontrada* scheduled on April 12, 13, and 14, 2022 at Sorsogon Cockpit Coliseum, Brgy. Bibincahan, East District, Sorsogon City;

**WHEREAS**, as per consensus, a certain amount of the total share of the requesting party from the derby shall be reserved and retained by the Committee on Games and Amusement through the owner of the cockpit and shall be given to the respective requesting party and that the party shall faithfully comply therewith;

**WHEREAS**, pursuant to Inter Agency Task Force on Covid19 (IATF) Resolution No. 154, Series of 2021 and to the existing laws and regulations and as provided by Republic Act 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Panlungsod has the power to regulate the conduct of cockfighting within the territorial jurisdiction of the City;

**WHEREAS**, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution approving and authorizing the conduct of *encontrada* on scheduled on April 12, 13, and 14, 2022 sponsored by Senior Citizen Association of Brgy. Guinlajon, West District, Sorsogon City at Sorsogon Cockpit Coliseum, Brgy. Bibincahan, East District, Sorsogon City;

**NOW THEREFORE**, on incidental motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Danilo A. Deladia**, resolved as it is hereby resolve to approve and authorize the conduct of *encontrada* scheduled on April 12, 13, and 14, 2022 sponsored by Senior Citizen Association of Brgy. Guinlajon, West District, Sorsogon City at Sorsogon Cockpit Coliseum, Brgy. Bibincahan, East District, Sorsogon City;
