RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH, BICOL CENTER FOR HEALTH DEVELOPMENT, REPRESENTED BY ITS DIRECTOR IV, ERNIE V. VERA, MD, MPH, CHA, CESO III, RELATIVE TO THE CONSTRUCTION OF THE SORSOGON CITY SUPER HEALTH CENTER.

WHEREAS, among the items deliberated during the April 05, 2022 Regular Session of the 7th City Council is a letter-request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City, addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the

Sangguniang Panlungsod thru Mr. Rovan E. Domasian, SP Secretary dated March 28, 2022, respectfully requesting for the passage of a resolution authorizing her to enter into a Memorandum of Agreement (MOA) with the Department of Health, Bicol Center for Health Development, represented by its Director IV, Ernie V. Vera, MD, MPH, CHA, CESO III, relative to the construction of the Sorsogon City Super Health Center;

WHEREAS, it is stipulated in the MOA, that the allotment of Six Million Five Hundred Thousand Pesos (P6,500,000.00) for the construction of the said edifice has been approved by the Department of Budget and Management (DBM) and that the same shall be downloaded to the City Government;

WHEREAS, considering that such edifice shall be of great help to the residents of Sorsogon City in terms of medical and health services, the City Government of Sorsogon intends to comply with the documents required to facilitate the download of funds;

WHEREAS, the Health Facility Enhancement (HFEP) is one of the major pillars of the "FOURmula One Plus for Health (F1+)" which aims to improve access to quality services and to attain goals outlined in the Philippine Development Plan 2017-2022;

WHEREAS, since CY 2007, the DOH has upgraded government health facilities to include Barangay health Stations, Rural Health units, District Hospitals, Provincial Hospitals and the DOH Hospitals and other health facilities;

WHEREAS, attached to the letter is a copy of a draft Memorandum of Agreement (MOA) for further perusal of the 7th City Council;

NOW THEREFORE, on incidental motion of Hon. Franco Eric O. Ravanilla, duly seconded by Hon. Mary Ellen D. Jamisola resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Department of Health, Bicol Center for Health Development, represented by its Director IV, Ernie V. Vera, MD, MPH, CHA, CESO III, relative to the construction of the Sorsogon City Super Health Center;
