RESOLUTION ISSUING TRICYCLE FRANCHISE TO NINE (9) QUALIFIED WAITING APPLICANTS FROM PREVIOUSLY CANCELLED/REVOKED TRICYCLE FRANCHISES UNDER SP RESOLUTION NO. 118, SERIES OF 2022 IN ACCORDANCE WITH CITY ORDINANCE NO. 22, SERIES OF 2020 OTHERWISE KNOWN AS THE “SORSOGON CITY NEW TRICYCLE FRANCHISE CODE OF 2020”

WHEREAS, SP Resolution No.118, Series of 2022, approved on April 5, 2022 officially cancelled and revoked tricycle franchises in favor of the city government of Sorsogon, in accordance with City Ordinance No. 22, Series of 2020 otherwise known as the “Sorsogon City New Tricycle Franchise Code of 2020”;

WHEREAS, on March 22, 2022, the Tricycle Franchising Regulatory Office through the SP Committee on Tricycle Franchise endorsed the nine (9) qualified waiting applicants for the aforesaid cancelled/revoked tricycle franchises, to wit:

1. **Tricycle Franchise No. 0706/Tricycle Franchise Plate No. 0706** awarded in the name of ALEX C. DOCTOR JR. of San Roque B. D. Sorsogon District, with the route covered by PTODA
2. **Tricycle Franchise No. 2411/Tricycle Franchise Plate No. 2411** awarded in the name of MELITO B. REDULLA of Piot, W. D. Sorsogon District with the route covered by PTODA.
3. **Tricycle Franchise No. 1665/Tricycle Franchise Plate No. 1665** awarded in the name of JAYSON D. BORBON of San Juan East, D. Sorsogon District, with the route covered by STDOVA.
4. **Tricycle Franchise No. 3291/Tricycle Franchise Plate No. 3291** awarded in the name of MARIA TERESA D. ORBINO of Talisay, W. D. Sorsogon District, with the route covered by PAMPTODA.
5. **Tricycle Franchise No. 0962/Tricycle Franchise Plate No. 0962** awarded in the name of AUGUSTO A. BARRIOS of Macabog, W. D. Sorsogon District, with the route covered by MATRIODAS.
6. **Tricycle Franchise No. 4399/Tricycle Franchise Plate No. 4399** awarded in the name of LOURDES L. LABRADOR of Barayong, W. D. Sorsogon District, with the route covered by PTODA.
7. **Tricycle Franchise No. 3373/Tricycle Franchise Plate No. 3373** awarded in the name of ARIANE ROCO of Guinlajon, W. D. Sorsogon District, with the route covered by GUINPABTODA.
8. **Tricycle Franchise No. 1116/Tricycle Franchise Plate No. 1116** awarded in the name of CHRISTIAN D. LEGASPI of Capuy, W. D. Sorsogon District, with the route covered by SIKWA.
9. **Tricycle Franchise No. 2284/Tricycle Franchise Plate No. 2284** awarded in the name of MARIVIC P. LEGASPI of Pangpang, W. D. Sorsogon District, with the route covered by PVTAS.

WHEREAS, Section 14 of City Ordinance No. 22-2020 (“Sorsogon City New Tricycle Franchise Code of 2020”) provides that The Sangguniang Panlungsod shall issue/grant franchise to operate a motorized tricycle for hire to qualified persons who desire to provide transport service to the general public by means of a motorized tricycle for monetary consideration. Being a privilege, it can be revoked, cancelled or withdrawn unilaterally at any time upon reasonable grounds;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Erwin J. Duana**, resolved as it is hereby resolve to issue tricycle franchise to nine (9) qualified waiting applicants from previously cancelled/revoked tricycle franchises under SP Resolution No. 118, Series of 2022 in accordance with City Ordinance No. 22, Series of 2020 otherwise known as the “Sorsogon City New Tricycle Franchise Code of 2020”.
