RESOLUTION RESPECTFULLY REQUESTING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO DEVELOP A BIKE, ROLLER AND SKATEBOARD RAMP AND OBSTACLE COURSE AT THE ROMPEOLAS AND WITHIN THE PUBLIC AMUSEMENT PARKS IN THE CITY OF SORSOGON

WHEREAS, biking and roller or skateboarding activities promote development and learning for the sports enthusiasts to use large muscles to move and balance own body;

WHEREAS, bike, roller and skateboard ramps and obstacle course is intended for interaction and independent play for all ages;

WHEREAS, outdoor obstacle courses are a great way for kids and adults to get a full-body workout and thereby makes them stronger and enhances their sense of balance and motor skills;

WHEREAS, outdoor obstacle courses further help children solve problems as they learn how to maneuver up, over, or through obstacles and they also learn how to adjust to changing conditions and memorize the fastest way to progress through the course;

WHEREAS, an obstacle course is also a great opportunity for children to develop their sensory processing skills;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitants;
