### Resolution No. 154, Series of 2022

RESOLUTION RESPECTFULLY REQUESTING THE MANAGEMENT OF SM CITY – SORSOGON TO PROVIDE FREE OF CHARGE MOVIE TREAT TO PERSONS WITH DISABILITIES (PWDs) OF THE CITY OF SORSOGON DURING THEIR FIRST CINEMA EXPERIENCE IN THE MALL AND ANOTHER 10% DISCOUNT SUBSEQUENT THEREON IN ADDITION TO THE EXISTING AND PREVAILING DISCOUNTS AS MANDATED BY LAW

**WHEREAS**, the Philippine Congress enacted Republic Act No. 7277, an Act providing for the rehabilitation, development and self-reliance for disabled person and their integration into the mainstream of Society;

**WHEREAS**, the Philippine Congress likewise enacted Republic Act No. 9422, an Act amending Republic Act No. 7277, otherwise known as the "Magna Carta for disabled persons and for the other purposes";

**WHEREAS**, the Philippine Congress further enacted Republic Act No. 10754, an Act expanding the benefits and privileges of persons with disability (PWD);

**WHEREAS**, it is a declared policy of the city government of Sorsogon to give full support to the improvement of wellbeing and integration into the mainstream of the society of Persons with Disabilities (PWDs);

WHEREAS, as part of its corporate social responsibility, SM City-Sorsogon is hereby requested to provide a one-time free of charge movie treat to senior PWDs of the City of Sorsogon during their first cinema experience in the mall starting from its opening day and another 10% discount subsequent thereon in addition to the existing and prevailing discounts as mandated by law;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitants;

**NOW THEREFORE**, on motion of **Hon. Fernando David H. Duran**, **III** duly seconded by **Hon. Mary Ellen D. Jamisola**, resolved as it is hereby resolve to respectfully request the management of SM City – Sorsogon to provide free of charge movie treat to senior Persons with Disabilities of the City of Sorsogon during their first cinema experience in the mall and additional 10% discount subsequent thereon in addition to the existing and prevailing discounts as mandated by law.
