### **RESOLUTION APPROVING THE REQUEST FOR ACCREDITATION OF PENAFRANCIA MUSSELS FARMERS ASSOCIATION.**

**WHEREAS**, among the items deliberated during the April 05, 2022 Regular Session of the 7th City Council is the inclusion made by Hon. Mary Ellen D. Jamisola, City Councilor, Chairman of the Committee on Livelihood, Cooperatives, POs, GOs and NGOs regarding the letter of Ms. Perlita Gopez, President of Penafrancia Mussels Farmers Association, addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City dated April 04, 2022, requesting for accreditation of Penafrancia Mussels Farmers Association by the Sangguniang Panlungsod;

**WHEREAS, PENAFRANCIA MUSSELS FARMERS ASSOCIATION** has applied for accreditation at the Sangguniang Panlungsod Sorsogon City pursuant to Memorandum Circular No. 2007-89 dated February 1, 2011 of the Department of the Interior and Local Government (DILG);
