RESOLUTION ADOPTING THE LOCAL DISASTER RISK REDUCTION MANAGEMENT PLAN (LDRRMP) FOR SPECIAL TRUST FUND BALANCES FROM LDRRMP CYs 2021, 2020, 2018 AND 2017 AND ITS CORRESPONDING LOCAL DISASTER RISK REDUCTION MANAGEMENT FUND INVESTMENT PLAN AND THE LOCAL DRRM FUND INVESTMENT PLAN FOR CY 2022

WHEREAS, on April 5, 2022, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City and the Honorable Members of the Sangguniang Panlungsod respectfully requesting among others, adoption and approval of the Local Disaster Risk Reduction Management Plan (LDRRMP) for Special Trust Fund balances from LDRRMP CY's 2021, 2020, 2018 and 2017 and its corresponding Local Disaster Risk
