RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A TRIPARTITE MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE STATISTICS AUTHORITY (PSA) AND THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) RELATIVE TO THE IMPLEMENTATION OF THE COMMUNITY – BASED MONITORING SYSTEM (CBMS).

WHEREAS, among the items deliberated during the February 22, 2022 Regular Session of the 7th City Council is the Transmittal No. 04, 2022 from the Office of the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City dated February 16, 2022 addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the Sangguniang Panlungsod thru the SP Secretary,

requesting for the passage of a Resolution authorizing the Local Chief Executive to enter into a Tripartite Memorandum of Agreement (MOA) with the Philippine Statistics Authority (PSA) and the Department of the Interior and Local Government (DILG) relative to the implementation of the Community-Based Monitoring System (CBMS);

WHEREAS, the Community-Based Monitoring System (CBMS) is an organized technology-based system of collecting, processing and validating necessary disaggregated data that may be used for planning, program implementation and impact monitoring at the local level while empowering communities to participate in the process;

WHEREAS, the Philippine Statistics Authority (PSA) shall be the lead agency in the implementation of the Community-Based Monitoring System pursuant to Republic Act (RA) No. 11315 also known as the CBMS Act;

WHEREAS, Rule VI, Section 7 of the Implementing Rules and Regulations of the CBMS Act tasked the Department of the Interior and Local Government (DILG) to develop and implement information and education campaign relating to CBMS thus ensure compliance of the LGUs in the various CBMS activities and extend assistance to PSA in the conduct and implementation of the CBMS;

WHEREAS, Section 4 of the CBMS provides that the Local Government Unit (LGU) is the primary data collecting authority within its locality;

WHEREAS, attached to the letter is a copy of a draft Memorandum of Agreement (MOA) for further perusal of the 7th City Council;

NOW THEREFORE, on motion of **Hon. Hilario D. Dioneda** duly seconded by **Hon. Erwin J. Duana** resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Tripartite Memorandum of Agreement (MOA) with the Philippine Statistics Authority (PSA) and the Department of the Interior and Local Government (DILG) relative to the implementation of the Community-Based Monitoring System (CBMS);
